



## **MISSION TRIP LIABILITY WAIVER AND RELEASE AGREEMENT**

### **Get Strong Ministries**

This Liability Waiver and Release Agreement (“Agreement”) is entered into by and between Get Strong Ministries, its directors, officers, employees, volunteers, agents, representatives, and affiliates (collectively referred to as “Get Strong Ministries”), and the undersigned participant (“Participant”).

### **1. Acknowledgment of Risk**

Participant understands and acknowledges that participation in a mission trip involves inherent risks, including but not limited to travel-related risks, illness, injury, property damage, accidents, acts of third parties, acts of God, political instability, and other unforeseen events. Participant voluntarily assumes full responsibility for any risk of loss, injury, or damage that may be sustained while participating in the mission trip.

### **2. Release and Waiver of Liability**

Participant hereby releases, waives, discharges, and covenants not to sue Get Strong Ministries from any and all liability, claims, demands, damages, costs, or causes of action arising out of or related to any loss, damage, injury, or death that may be sustained while participating in the mission trip, whether caused by negligence or otherwise, to the fullest extent permitted by law.

### **3. Indemnification**

Participant agrees to indemnify and hold harmless Get Strong Ministries from any claims, actions, damages, or liabilities arising out of Participant’s conduct during the mission trip.

### **4. Compliance with Rules**

Participant agrees to comply with all policies, instructions, and leadership decisions of Get Strong Ministries during the mission trip.

### **5. Photo and Media Release**

Participant grants Get Strong Ministries the irrevocable right and permission to photograph, videotape, and/or record Participant during the mission trip and to use Participant’s name, image, likeness, voice, and statements in any and all media, including but not limited to print, digital, social media, website, promotional materials, newsletters, and fundraising materials, without compensation.

Participant understands that these materials may be used for promotional, educational, ministry, and fundraising purposes and may be distributed worldwide. Participant waives any right to inspect or approve the finished product and releases Get Strong Ministries from any claims arising out of the use of such media.



## 6. Governing Law

This Agreement shall be governed by and interpreted in accordance with the laws of the State of Tennessee.

## 7. Severability

If any portion of this Agreement is found to be unenforceable, the remaining provisions shall remain in full force and effect.
